\*4 The limit password is required for various settings, such as billing plans with a limit function and also to configure settings for Access Restriction Customizer, etc. If a limit password is already in use, re-registration will not take place.

With the limit password, the user will be capable of changing which sites can be accessed, or raising the limit, etc. Therefore, we ask the legal representative to call the Limit Service Center to change the limit password accordingly. Please be cautious in handling the password.

\*5 The legal representative may be contacted for confirmation at the time of application.
