 *3. If you choose DOCOMO's installment payment option, your payment method must be by bank account transfer or credit card.
 *4. If the subscription is in an individual's name and DOCOMO's installment payments will be used to purchase a product costing more than ¥100,000 (incl. tax), DOCOMO will confirm the information required for the screening process (size of family, whether living together, income/loan status, payment of home loan/rent).
 *5. For FOMA service subscribers only. Furthermore, the subscriber must agree to use the applicable handset for 24 months, based on the Basic Course stipulations. If the model is changed, subscription is cancelled, etc. within this period, the Basic Course cancellation fee (¥630 [incl. tax] × no. of remaining months) will apply.
 *6. Access Restriction Service (Filtering Service) is a service to restrict access to sites such as dating sites and harmful sites (application required / no monthly charge). In principle, application for this service is required in accordance with the implementation of the Act on Secure and Safe Internet Use Environment for the Youth. Furthermore, if no selection is made, intention to apply for i-mode Filter/sp-mode Filter/ ANSHIN Filter for docomo /BlackBerry Web Filter will be assumed and the service will take effect.
 *7. The Limit password is required when configuring settings for billing plans with a limit function, Access Restriction Customizer, etc. If a Limit password is already in use, a new password will not be registered. Users who know their Limit password will be able to change which sites can be accessed, raise the usage limit, etc. on their own. Therefore, legal representatives should change the password at the Limit Service Center as necessary. Please keep the password safe.
 *8. Through Internet use, young people may be exposed to potentially harmful information detrimental to a healthy upbringing. Please bear this in mind if you do not use or plan to stop using Access Restriction Service.
 *9. The legal representative may be contacted for confirmation at the time of application.
