 - (2) The user may suffer damages, including leaks of personal information or the infringement of portrait rights, through actions such as exchanging information with strangers using profiles, SNS, or other websites.
 - (3) The user may become a perpetrator if irresponsible entries on blogs, bulletin boards, or other websites that identify individuals lead to libel, slander, or defamation.
 - (4) The user may be accused of forcible obstruction of business, criminal intimidation, or other offenses by posting an advance notice of a crime, a mischievous entry, or other messages for mere amusement.
 Risks are not limited to the aforementioned.
